Shaheed Benazir Bhutto University (SBBU) Shaheed Benazir Abad (SBA), an institution existing under the laws of the Islamic Republic of Pakistan, having its office SBBU SBA Campus, near Landhi Stop Sakrand Road, Shaheed Benazir Abad.

بورڊ آف گورنرس، اداري جو اعليٰ پاليسي ساز فورم آهي، جڏهن ته مختلف ڪميٽيون، اداري جي ڪاروهنوار کي هلائڻ لاءِ جوڙيون ويون آهن، جن ۾ اشاعتي ڪميٽي، سنڌي صورتخطي، رسم الخط ۽ وبا ڪرن ڪميٽي، مالي ڪميٽي، سليڪشن ڪميٽي ۽ ايوارڊ ڪميٽي شامل آهن.

The Parties named herein desire that an MOU be formalized based on the headings as hereinafter appearing.



The Parties have reached the following understandings:

Article 1

Statement of Purpose

- 1.1 Sindhi Language Authority, Hyderabad and SSBU SBA recognize that the Parties have many interests in common and that there will be mutual benefits from academic collaboration and cooperation.
- 1.2 This MOU provides the mechanism through which the expressed intent of the Parties can be realized.

Article 2

The Subject Areas

- 2.1. The subject areas for potential collaboration and cooperation have been identified as, but not limited to, the following activities:
 1. Exchange of academic opportunities in any form of research collaboration.
 2. Perform Joint research, research projects, and publications
 3. Joint conferences, cultural exchange programs, and consultancy services
 4. Inter-institutional training, online teaching, and webinars
 5. Joint programs at the undergraduate and postgraduate levels
 6. Scholarships for students doing research on Sindhi Language
 7. Sindhi Linguistics based Training/ workshops of Students
 8. Sindhi Linguistics based internships of Students
 9. Joint community services
 10. Consultancy opportunities
 11. Any other areas of cooperation to be mutually agreed upon by both the parties.
- 2.2 Each mutually identified and agreed activity, shall be covered by separate Agreement(s) which will be an annex to this MOU. The terms and conditions under which a specific program and activity shall be undertaken under the terms of this MOU and any necessary financial arrangements to facilitate these will be mutually discussed and agreed upon in writing and approved by the Parties before the initiation of the particular program or activity.



Article 3

Co-ordination of this MOU

- 3.1 The Parties to this MOU will, within a reasonable time from the date of execution of this MOU, designate a key contact person on behalf of each Party who will take responsibility for the development and achievement of the Objectives of this MOU and when mutually agreed, will take responsibility for the development of the separate Agreement(s). Each party shall be liable for its costs and expenses, if any.

Article 4

Terms of this MOU

- 4.1 The term of this MOU shall be for **Five (5) years** in the first instance.
- 4.2 This MOU will be automatically extended for the same length of time if it is not terminated in writing by either party.
- 4.3 Either Party may terminate this MOU at any time by giving not less than **Three (3) month's** notice in writing. At the end of the three (3) month period calculated from the date of the said notice, this MOU shall be terminated.
- 4.4 It shall be the duty of each Institution to make its best endeavours to protect the interests of all students from the other Institution who have acted upon any collaborative arrangements hereunder notwithstanding the expiry or early termination of this MOU.

Article 5

Financial Matters Relating to this MOU

- 5.1 Unless otherwise agreed, each Party shall be responsible for its financial contributions during the implementation of this MOU.

Article 6

Disclaimer

- 6.1 Nothing shall diminish the full autonomy of either Party or will any constraints or financial obligations be imposed by either Party upon the other in carrying out this MOU.
- 6.2 The Parties agree that this MOU will act only as an interim understanding until further Agreement(s) is reached for the separate activities identified within this MOU.



- 6.3 The Parties hereto shall keep in confidence all information disclosed to the other Party or exchanged and neither Party shall without the consent of the other Party release any such information to any third party other than those duly authorized for the purposes herein.
- 6.4 Nothing in this MOU shall prohibit either Institution from entering into similar collaborative arrangements with any third party in respect of the subject matter herein.

Article 7

Nature of MOU

- 7.1 This MOU shall be construed as a statement of intent and is not binding on either Party but rather to describe and nature and suggest guidelines for mutually beneficial cooperation.
- 7.2 This MOU relates only to the intention contemplated herein and nothing contained herein shall be deemed to create an association, partnership, or principal/agent relationship between the Parties hereto or impose any partnership obligations or liability to either Party. Neither Party shall have any right, power, or authority to enter into any agreement of commitment, act on behalf of, or otherwise bind the other Party in any way until Separate Agreement(s) has or have been reached between the Parties.

Article 8

Miscellaneous

- 8.1 The Parties recognize that it is impractical to make provision for every contingency that may arise in the course of the performance of the provisions hereof and accordingly declare their intention that this MOU shall operate with fairness between them and without detriment to the interest of either Party and that each Party will endeavour to ensure that full effect is given to the terms of the MOU in the spirit in which it was initially agreed.
- 8.2 No exercise or failure to exercise or delay in exercising any right, power, or remedy vested in any Party under or according to this MOU shall constitute a waiver by the Party of that or any other right, power, or remedy.
- 8.3 This MOU shall be governed by and construed with the prevailing laws and regulations in the relevant country in which the activity is being undertaken
